The proposed Work includes the following: Approximately 14,630 syd of asphalt pavement reclamation, 3,400 tons of asphalt paving, pavement marking, drainage improvements and site restoration.

## **Bidder Qualifications**

Bidders shall submit evidence of qualification meeting the requirements of General Contract Provisions 20-02. Possession by the prime contractor of MDOT prequalification at the time of bidding shall be an acceptable form of evidence. This project includes Designated Item classifications of 1600 Cb (Hot Mix Asphalt/Bituminous Paving) and 1600 Ea (Grading, Drainage Structures and Aggregate Construction). In addition, this project includes Specialty Item Classification 1600 N9-2d (Crushing and Shaping).

If the prime bidder is not prequalified in the Designated Item classification(s), then it must use a subcontractor that is prequalified in such classification(s). This subcontractor must be designated prior to award of the contract to the confirmed low bidder. See "Bidder's Qualifications" in the proposal forms for further information.

There is a Disadvantage Business Enterprise (DBE) participation goal of 5.0% for this project.

A Non-Mandatory Pre-Bid Conference for this project will be held on **February 6, 2025, at 2:00 p.m.** (local time) at the **Mason Jewett Field Airport**.
